THE BELOW NAMED COMPLAINANT BEING DULY SWORN, ON INFORMATION AND BELIEF STATES THAT:

**Count 1: TAKE VEHICLE WITHOUT OWNER'S CONSENT BY USE OR THREAT OF FORCE**

The above-named defendant on or about Thursday, November 07, 2019, at 2200 East Kenwood Blvd, in the City of Milwaukee, Milwaukee County, Wisconsin, by use of force against another or by the threat of use of force against another, did intentionally take a vehicle without the consent of the owner, contrary to sec. 943.23(1r), 939.50(3)(e) Wis. Stats.

Upon conviction for this offense, a Class E Felony, the defendant may be fined not more than Fifty Thousand Dollars (\$50,000), or imprisoned not more than fifteen (15) years, or both.

**Probable Cause:**

Complainant is an employee of the University of Wisconsin-Milwaukee Police Department and bases this complaint on information and belief and on a review of official police reports prepared by University of Wisconsin-Milwaukee Police Officers which are the kind Complainant has used in the past and found to be truthful and reliable and which Complainant knows were prepared in the ordinary and regular course of police business.

Officer Jeanne Parsons's reports indicate that on November 7, 2019, at approximately 5:40 PM, she and Officer Weaver were dispatched to the University of Wisconsin-Milwaukee Student Union Parking Structure, located at 2200 East Kenwood Boulevard, in the City and County of Milwaukee. While en route, dispatch updated Officer Parsons that a witness saw the suspect currently walking southbound in the 3000 block of North Farwell Avenue. Officer Parsons spoke to the witness JHT on the phone, who gave a description of the suspect and continued to update officers as to the suspect's location. JHT saw the officers pull up by the suspect that said, "You got him," confirming the suspect's identity.

Officer Parsons exited the squad car and the suspect, later identified as the above-named defendant, fled on foot. A foot pursuit began, with other officers responding as well. Officer Steven Ohland's reports indicate that he gave multiple commands of "Police! Stop!" to which the defendant did not comply. The defendant was stopped by a tall fence. Officer Ohland gave multiple commands for the defendant, to which the defendant did not comply. Officer Ohland observed the defendant holding a black and yellow screwdriver and observed the defendant throw the screwdriver. The defendant then physically resisted Officer Ohland before being taken into custody. The screwdriver and a flashlight were recovered.

Officer Parsons spoke with ICB. ICB stated that he had parked and locked his vehicle in the parking structure around 11:00 AM and was returning from class around 5:30 PM. ICB discovered that his vehicle was no longer in its parking spot but observed the reverse lights of the vehicle activated. ICB observed the vehicle pull out of the parking lot and drive southbound in the parking structure, while ICB chased after his vehicle. The vehicle, driven by the defendant, attempted to exit through an entrance gate and was unable to do so.

ICB opened the front passenger door and ordered the defendant to exit ICB's vehicle. The defendant refused to exit the vehicle. The defendant then placed his right hand in his coat pocket and stated, "I got a gun." The defendant then began to reverse the vehicle, causing ICB to have to jump out of the way and hold onto the top luggage rack. At this time, JHT, a UW-M parking employee, arrived on scene. The defendant exited the vehicle and fled on foot.

This incident was captured on surveillance video, reviewed by Officer Parsons. ICB can be seen arguing with the driver of the vehicle, the vehicle reverses and the passenger door strikes ICB, causing ICB to jump onto the vehicle's running board and grab the luggage rack, before the suspect exits the vehicle.

ICB's vehicle had the back passenger window broken out, with glass inside the backseat. The same type of glass with the same tint was located in the spot that ICB stated he had originally parked the vehicle. ICB stated that he had a spare key to the vehicle in the glovebox, which he recovered from the ignition. ICB did not give consent to have his car stolen or his life threatened. ICB gave a detailed description of the suspect and later identified the defendant in a photo array.

Officer Parsons conducted a Mirandized interview of the defendant. Officer Parsons informed the defendant would be referred down for an armed robbery charge. The defendant replied, "Armed robbery?" Officer Parsons stated that ICB had reported that the defendant had stated that he had a firearm during the robbery. The defendant replied, "I can say whatever I want." The defendant then called Officer Parsons a "fucking bitch" and ended the interview.
